

SCO is committed to protecting and expanding children's educational options through ensuring choice in quality schools and other places of learning, thereby supporting systemic reform of K-12 education across the state.

With the state's four scholarship programs—The EdChoice Scholarship Program, The Cleveland Scholarship and Tutoring Program, The Autism Scholarship Program, and the new Jon Peterson Special Needs Scholarship—Ohio's students now more than ever before are able to find an educational environment that best suits their needs.

School Choice Ohio hit the road in May on a statewide tour to visit schools located in six cities across Ohio: Cleveland, Akron, Columbus, Lima, Cincinnati, and Dayton.

We invited media to each school to speak with school leaders, families, students, and SCO staff about Ohio's school choice programs. SCO stressed the need for bold school choice expansion language to be included in the state budget. School leaders spoke about the importance of the state scholarship programs, and parents shared their compelling personal stories.

State Representatives Matt Huffman and Lynn Wachtmann attended the Lima tour stop at Temple Christian School. Rep. Huffman talked to the crowd about the major voucher expansion proposal that he sponsored with bipartisan support.

In total, seventeen media outlets attended the three-day tour events, which resulted in three front page stories, coverage on 12 major television stations, and overall exposure to more than 2,000,000 households.

2011 brought momentous changes and expansions to Ohio's school choice programs as Governor Kasich signed the Ohio budget bill into law. The budget created Ohio's fourth school voucher program and expanded two of the state's existing voucher programs. As a result, eligibility for vouchers in the Buckeye State will jump from 126,000 to almost 375,000 eligible students. The number of scholarships available to Ohio's families will also quadruple to nearly 80,000 spots.

The budget created Ohio's fourth school voucher program to provide scholarships for K-12 students with special needs. Named for a former state representative who advocated for the scholarship during his tenure in the Statehouse, the Jon Peterson Special Needs Scholarship will provide a scholarship to any child with special needs who has an Individualized Education Program (IEP).

In addition to the creation of the new scholarship program, the budget expanded two existing scholarship programs. The EdChoice Scholarship Program will quadruple the number of scholarships available during the next two years to allow 60,000 scholarships by the 2012-13 school year. Eligibility for EdChoice also expanded to include students who attend schools in the bottom 10 percent of the state, according to Performance Index scores.

The Cleveland Scholarship and Tutoring Program saw long-awaited improvements, including an \$800-\$1,550 per student increase in the scholarship amount to mirror the EdChoice Scholarship. Previously limited to students entering grades K-8, the program is now open to students in any grade.

School Choice Ohio applauds the work of the Ohio legislature and Governor Kasich on this budget. Many more Ohio families will now have the chance to find the best learning environment for their child. These changes are a move in the right direction for Ohio.

The Jon Peterson Special Needs SCAC LASAL Program

When Governor John Kasich signed the state budget into law on June 30, 2011, he finalized the creation of the Jon Peterson Special Needs Scholarship Program. Now, any student with special needs who has an IEP will be able to access a scholarship like those already available to students with autism.

Approximately 12,000 scholarships will be available, and each scholarship will be worth up to \$20,000. The scholarship can be used to pay for tuition at a private school, additional services at a private provider, or at other public schools. The importance of this scholarship for Ohio's families and students with special needs cannot be overstated. Parents will now have the chance to find the education setting that is most appropriate

for their children. Students with disabilities will now have access to options tailored to their special needs—either mainstream environments or specialized schools. And, rather than having to fight through a lengthy legal process to secure the services their children need when their public school isn't working, families will now be able to direct part of the tax dollars already set aside for their children's education to the school of their choice.

We are so happy to celebrate with families across the state who have worked hard for so many years to make this scholarship a reality. Their vision of a scholarship that places students' needs at the center of their education and empowers parents with options led them to write letters sharing their stories, testify at public hearings at the Ohio Statehouse, call key decision

makers and urge their support, and meet individually with legislators time after time to show why this scholarship is so important to so many families.

In honor of these families, SCO hosted a dinner in November 2011 to celebrate the monumental achievements and dedicated work of the scholarship's namesake, former Ohio Representative Jon Peterson. Parents and advocates talked about the difference the Autism Scholarship has already made in their children's lives. They also shared their excitement for the Special Needs Scholarship, because it will allow more families to access the education they know is best for their children.

This new Special Needs Scholarship Program will open **up doors for our children,** let us make the school choices and reduce the anxieties we feel as parents to find the best school to address the special needs and learning styles of our children. Our thank you to all, especially to former Representative Jon Peterson, for persevering and making this important program work for our children.

Income-based Scholarships

School choice is limited by families'
ZIP codes and incomes. When
they can't afford to move to a
neighborhood with better schools or
pay private school tuition, families are
stuck with an education option that
isn't working well for their child.

In Ohio, we're fortunate to have the EdChoice Scholarship that allows students assigned to the very lowest-rated public schools to access a private school scholarship.

But what about students who aren't thriving in their school even though it's not rated in the absolute bottom? Or maybe the school is even highly rated, but it is still not a good fit for whatever reason? Perhaps it's a gifted student attending one of the many Excellent-rated schools that have no students taking Advanced Placement courses. Perhaps it's a student who's struggling to catch up but isn't getting the help he or she needs. Or maybe it's a student who is being bullied.

Introduced by Representative Matt Huffman of Lima, the Parental Choice and Taxpayer Savings Scholarship (PACT), seeks to broaden the base of students eligible for statewide scholarships. With the newest adjustments, PACT vouchers will be available at an equal or lesser value than state aid per pupil spending in each district. The number of scholarships will be limited to 1 percent of district enrollment, and students from families with yearly salaries up to 300 percent of the federal poverty level, or \$67,050 for families of four, are eligible.

This proposal would give many parents the opportunity to choose an educational environment that best meets their needs rather than conforming to a one-size-fits-all model. SCO looks forward to working with legislative supporters in 2012 to provide greater options for Ohio's students.



Looking Ahead

In addition to the very important PACT scholarship, SCO hopes to make even greater strides toward school choice and educational freedom for Ohio in 2012.

1. Access: Create Statewide Income-based Scholarship Program

Income-based scholarships would allow families in either private or public school who meet low income criteria to apply. All families throughout Ohio should have access to an income-based scholarship.

2. Funding: Address critical voucher funding disparities affecting student access

- Increase high school amount for Cleveland and EdChoice youchers
- Increase Autism and Special Education Scholarship to parity with public school amount
- Remove the parent co-pay in the Cleveland Voucher Program

3. Flexibility: Allow on-site/online "hybrid" school models to operate in Ohio

Exciting models of hybrid schools are operating successfully around the world to offer a more personalized, targeted education to students. Ohio families should have these same options.

4. Financing: Develop student-centered school funding model

A student-centered funding model develops per-pupil funding amounts that are based on individual student needs. Student-centered funding allows true parent choice by giving families full portability of their children's education funds.

5. Quality: Ensure more state-published school choice information for parents and the public

- Increase information available to parents, policymakers, and the general public about the range of available options
- The State of Ohio should track and report graduation rates and value-added data for voucher recipients and require school choice data to be made available for third-party research.

The World of Many

An organization is only as strong as those who stand with it to ensure its success. We are grateful to our board members, staff members, donors, interns, partners, fans, followers, and many volunteers across the state. Their combined efforts are dramatically expanding opportunities for Ohio students to access the school that is the best fit for them.

This year, we amplified our focus on advocacy and broadened the public role of SCO. We engaged in direct advocacy with legislative leaders, presenting testimony on multiple legislative proposals, participating in an increasing number of radio and newspaper interviews, and taking advantage of opportunities to delive public presentations to community organizations on the benefits of and need for school choice. Each of these activities served to raise public awareness of school choice and to increase the impact of the organization as a whole.

The timing of SCO's stepped-up and focused efforts coincided with a favorable change in political climate, and there is growing evidence that this confluence contributed to what has been a very successful year for school choice in Ohio. SCO learned a number of valuable lessons during this year that will not only benefit us moving forward but have the potential to benefit school choice organizations in other states.

Volunteers

More than 400 parents and school leaders are active across the state as volunteer community ambassadors with School Choice Ohio. This important coalition works tirelessly, sharing their stories with legislators, asking for bolder voucher proposals, inviting legislators to their schools to see the impacts of vouchers firsthand, testifying in legislative hearings at the Statehouse, and meeting with legislators one-on-one and in small groups. These volunteers are crucial to the on-the-ground work of SCO and played a pivotal role in our 2011 accomplishments.

Our volunteer Board of Directors continues to provide active, critical leadership and has been crucial in building goodwill for the efforts of SCO.

Donors

School Choice Ohio is also lucky to have the help of very dedicated financial supporters. In 2011, SCO was given \$100,000 in matching grants, a goal that we successfully reached. We operate with assistance from many valuable foundation supporters. In addition, SCO received numerous individual contributions from dedicated individual givers throughout the year.

Board and staff

SCO has seven staffers located in our central Columbus office and five regional staff members based in Akron, Cincinnati, Cleveland, Columbus, and Toledo that focus on local community outreach and grassroots mobilization.

The addition of a communications coordinator, Kaleigh Frazier, and the resulting increase in capacity paid dividends with a dramatic expansion of media attention to important issues related to school choice.

Our new legislative director, Jason

Warner, educates legislative leaders on the need for expanded options for families and has become an important resource for policymakers.


